To The Fixer:

I suppose that it is a comment on your recent article, "The Student as Nigger," that the single point which seems to have drawn the most reaction is the lament of the segregated restrooms. At the risk of appearing naive and of incurring the scorn of Mr. Rainey, I must admit that I am puzzled. I had no idea that students wanted to use the toilets side-by-side with the faculty members they professed so much scorn for. While the demand is certainly flattering, I would suggest that there are more appropriate places for the college community to gather than the rerified atmosphere of the restroom.

I also wonder if the complaint does not idealize the whole toilet procedure. It has always seemed to me that the life of the toilet is essentially a lonely and private experience which each individual must ultimately face alone. To make it into a communal happening is to distort its very nature. The ideal solution to what is admittedly an awkward problem would seem to be an individual--for every student, faculty member, and hired hand. Certainly, then, the more toilets that are available, and the more strictly they are limited, the closer we are to achieving this good.

Or perhaps the complaints result from wounded vanity and the lure of the unknown. If the latter, I can assure the students who are green with envy that faculty restrooms offer the same rough comforts and facilities as

When I learned of Mr. Hallman's letter to The Fixer I was both pleased and excited. I imagined his article to be similar to Mr. Lisle's in serious and intelligent discussion of the essay "Student As Nigger." Instead of being intelligent in approach, Mr. Hallman settles for humorous; in place of serious discussion, Mr. Hallman relies on being funny. Instead of trying to see that segregated restrooms are a readily visible example of the superior-inferior relationship between teacher and student, Mr. Hallman pens a "puzzled" article regarding the absurd notion of the students' "demand" to the use of faculty restrooms. Missing the main point Mr. Hallman attacks this issue with such as; "toilets side-by-side," "lonely and private experience," and "communal happening." All of which is rather humorous, partly because of the situation discussed and partly due to Mr. Hallman's choice of words, but none of which speaks to the real issue, the issue of students being treated as human beings rather than a small insignificant mass. #### VAGINAL INFECTIONS (PART I)

You've probably had an infection in your vagina or your bladder. Most women have. There are several common infections that aren't very serious but cause us an incredible amount of discomfort, pain and anxiety. Many of us feel very guilty about them and keep silent because we connect them with VD, but you can catch them from contact with feces and from dirty toilet seats or shared towels and washcloths.

Unfortunately complete treatment--drugs to combat the infection--means going to a doctor or clinic to get a prescription. And that means money, more or less depending on where you go, but money nonetheless. But knowing all the symptoms, causes and treatments of these infections helps us understand problems in our bodies that doctors too often do not have the time or inclination to explain properly.

In all women glands in the cervix and the membranes that line the vagina secrete moisture and mucus. This discharge is transparent or slightly milky and maybe somewhat slimy; when dry it may

look yellow. The secretion increases in a woman who is sexually aroused. It is normal discharge and causes no irritation or inflammation of the vagina or the vulva.

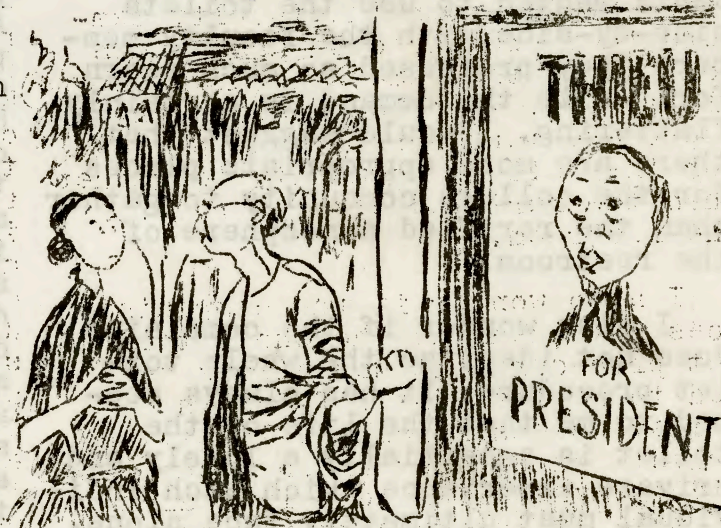
The cells of the cervix and vagina are affected by the female sex hormones, estrogen and progesterone, which are involved in the menstrual cycle. Therefore the amount and consistency of a woman's discharge may vary during her menstrual cycle and may also depend on her personal hormone balance.

A normal healthy woman of child bearing age has many different types of bacteria inside her vagina and the acidity keeps down some harmful bacteria. Constant douching or the use of vaginal sprays and deodorants can destroy these bacteria and upset the natural balance in your vagina, leaving it open to infection.

Being under 21 is an out for some people. It allows them to shirk their responsibilities and duties, which for their own sake, and for that of their peers, they ought to be coping with.

On the other hand, young people now are more willing, even anxious, than ever before to claim the rights and take on the tasks which belong to an American. Therefore the cry of many is power- "POWER TO THE PEOPLE"

Jesus Christ is interested in his people having power. The power that he is most interested in is personal power rather than collective. 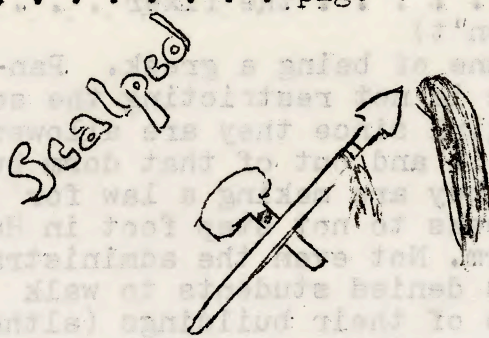

### Oklahoma Indians Protest School Board Ban on Long Hair

LAWTON, Oklahoma (LNS)--Indians in this city of 60,000 have been picketing the School Board building since Jan. 10 to demand the rights of Indian students to wear long hair in school. The picket is a result of Mrs. Frances Wise, an Indian resident of Lawton, and her battle with the school board over the length of her three son's hair. The school accepted late enrollment fees for the three boys and then refused to let them into school because of their hair.

When at the beginning of the fight, Mrs. Wise told the superintendent that her son's hair is an Indian tradition, he replied, "You're living in the past."

Mrs. Wise immediately contacted John Trudell of the Native American Movement and the two went through many legal channels but after weeks of stalling by the school board, the Indians began to picket.

Indians in Lawton, who make up 3% of the total population, have not been vocal in the past against anti-Indian city policies. But now Indians in near-by towns and colleges as well as Lawton itself are firmly behind Mrs. Wise and have come out in good numbers to join the picket lines--even in windy 15 degree weather.

During one of the first days of picketing, sixty high school students walked out of school to support the Indians and join the line, and on Jan. 15 cops arrested 15 Indians and 2 members of the Vietnam Veterans Against the War (VVAW) when they tried to go in the school board building. The seventeen arrested went on a hunger strike in the city jail until they were released on bond Jan. 17.

Lawton has three high schools, two of which allow students to wear long hair. But when the Indians began to protest the long hair ban, all three schools began to demand that students cut their hair.

The Native American Movement, the National Indian Youth Council, VVAW and Barrage, the Lawton-Ft. Sill area underground paper are also actively supporting the Indian's picket line.

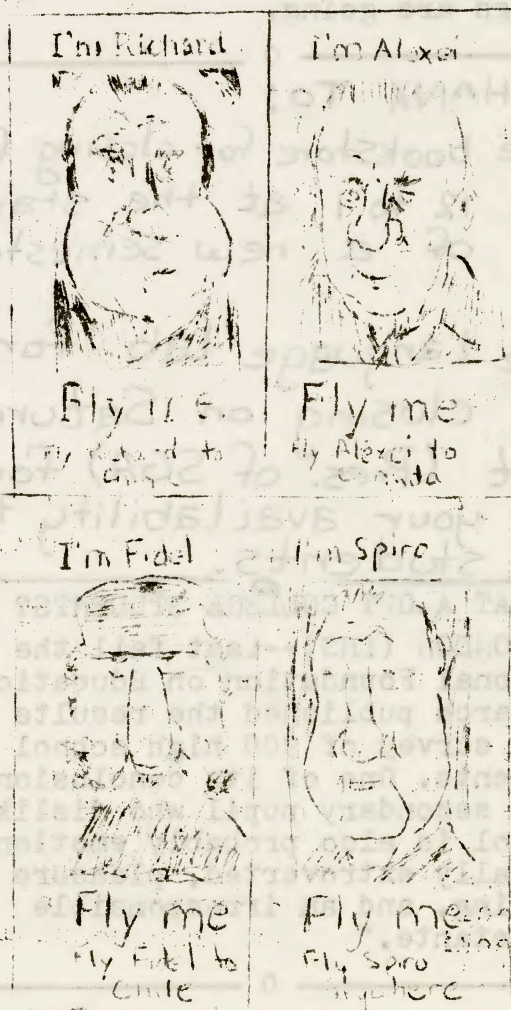

### The Great Society

That'll learn him--last Spring,

Dave Konkol, president of the Resident Student Council at St. Thomas College in St. Paul, requested an administration decision on proposed liberalization of dormitory rules. Receiving no response, Konkol wrote a letter suggesting the administration was afflicted by "bureaucratism, pettiness, paternalism and inefficiency." A reply from the dean stated: "You are wrong. This administration can make decisions. As proof of this, the administration has decided to cancel your financial aid grant for the coming year."

St. Thomas College was asserting the right of self-defense in canceling Dave Konkol's grant. The college president, Msgr. Terrence Murphy, explained: "In our college catalog it states that financial aid will be given on the basis of need and contribution to the purpose of the college. It was our judgment Konkol did not qualify on the second part. There is a limit to how much abuse we have to take." With a little grooming, that man could be another Nixon.

Fastest tongue in the Senate--Explaining the seeming contradiction between administration claims of winding down the war and stepped-up bombing of North Vietnam, Senate Republican leader Hugh Scott said it's like the guy who backs out of the saloon with his guns blazing. Then there's the fella who walks in backwards so it looks like he's leaving.

Especially with facts--Criticism has occasionally been directed against the Treasury practice of depositing millions and perhaps billions of dollars in a few favored banks without collecting interest. ### LAWYER'S LEVIS FREAK JUDGE

SAN FRANCISCO (Barb/UPS)--A hip young lawyer has been fined \$100 for coming to court in "work" clothes.

Peter Pipe, a 29 year-old San Francisco attorney, appeared in court Wed. Oct. 14 wearing a corduroy coat, a plain shirt, no tie, blue jeans, and shoes, "people's clothes--that half of the country goes to work in everyday."

The judge adjourned the case until Thurs. and warned Pipe to "wear a suit or go to jail!"

Pipe went back the next day dressed the same way. "I have a suit I could put on, but I won't cop out. This will cost me, but money isn't everything," he said, before going back to court.

"Lawyers walk in here with all kinds of gaudy outfits of silk and such."

"If we (lawyers) can't go into court looking the way our clients look, the hell with it."

Marvin County Municipal Judge Goldstein fined Pipe \$100 and gave his client--a drunk driving case--one day to get another lawyer.

"My client has been denied his right to choose his own lawyer," said Pipe.

"I told the judge that the courtroom isn't his, that it belongs to the people and he was interfering with the client's right to choose a lawyer as he sees fit, one dressed the same as him."

Pipe is appealing to a higher court.
