RACIST JUSTICE IN CHARLOTTESVILLE

In our September issus we printed an article entitled "Racist Justice In Charlottesville" in which we told how two Charlottesville policemen, Jeff Roberton and Dave Pleasants acted in a racist manner in arresting "Snake" Jones, and further cited several other incidents which had built officer Pleasant's notorious reputation for racism and brutality. For publically exposing this racism, we are now being sued by these policemen for \$200,000.00. Their lawyer, interestingly enough, is H.G. Haugh who, while having

enough time to represent and support the police in the libel suit didn't seem to have that same concern for a Black man who was brutally attacked by the police. The article below describes that attach and relates how in this society the VICTIM of injustice is treated like a criminal by the police, courts, and the law.

RACIST JUSTICE FROM RACIST POLICE

In December of 1969, Clarence Guyton, a Black man, was having a party in his house. The noise from it bothered no oneand no neighoors filed any complaints. Nevertheless. two policemen, Dave Pleasants and Jimmy Pace stopped their crusier, got out, went to Mr. Guyton's door, demanded

to be let in, and stopped the part After forcing some of the guest out, Officer Pace said, "Well we are going to take you downtown."
Mr. Guyton said, "For what? I ain't
going downtown, you don't have a warrant." At that point, Officer
Pace said, "Consider yourself unde arrest," and then both officers
Pace and Pleasants grabbed Mr. Guy
ton. Later, three more relief. ton. Later, three more police came and joined in the attack on this Black man

They beat him severely in his own house and then as they were dragging him out the front door-one officer had him by the legs,

> and one by the arms--Dave Pleasants struck Mr. Guyton in the head with his night stick inflicting a wound which was later mended with eigh stitches. Afterwards, the police stated that he had fallen down the steps in from of the house thus causing all of his injuries. But this is a lie because 1) there are no steps in front of the hous 2) the doctors have stated that the only way that he could have received his back injuries was from having his arm twisted--not from falling and 3) Dave Pleasants admitted. and bragged about having hit Mr. Guyton on the head. Following the bea ting at the house the police took Mr. Guyton to the hospital, fearing that he might die from loss of bloc in jail. Once at the hospital; according to Guytor "They started to whup up on me...

Once again, please come out and vote, TUESDAY, March 14, in the





LETTER FROM A RVN SOLDIER TO 1 IXO A D BUIKER: "A TRICAL DELOCRACY IS NOT ING TO BE PROUD OF" by Truong Trong Quang LNS

Editor's note: Whenever the U.S. government talks about Vietnamization. it talks about the increasing number of South Vietnamese soldiers (now pushing one million). But no one bothers to point out that a great many of the soldiers already in the South Vietnamese army are there against their will (drafted to fill the quota) and are openly hostile to the Saigon government. ernment and the U.S. presence in their country.

The following excerpted letter by a Vietnamese soldier in the Saigon Army responds to comments by President Nixon and U.S. Ambassador Ellswort Bunker about the one-man election held last September in Vietnam.

Bunker: "You can't expect too much from this underdeveloped country."

Mixon: "It'll take a few more generations before the Vietnamese can enjoy democracy."

This contemptuous attitude provoked a tremendous reaction in South Vietnam. Several reactions were translated and printed in Thoi Bao-Ga, a newsletter put out by Vietnamese students living in the U.S. Copies of the newsletter can be obtained from 76a Pleasant St., Cambridge, Mass. 02139.

Mr. President and Ir. Ambassador: V control abyon the transfer of the land of

After several nights of deliberation, I realize I must wake up my people and protest your contemptuous words by writing this open letter. If I do not, the frustration within me will explode in more violent and effective means of protest.

I cannot take action because I am a soldier bound by strict regulations I cannot march in the street waving banners or burning efficies like other young Vietnamese outside the regimented world of the army. But like them, I am proud of Vietnam... I have not forgotten my origins, and neither my conscience nor my heart are yet Sinicized, Frenchified, or Americanized. I still feel shame when my country and my people are scorned ...

The Americans arrived in this land after the signing of the Geneva Agreements, claiming to be helping my country in her right against the Communists, to be protecting the southern part of our country and to be providing "security" for nations on the other side of the ocean, including your own, but not to be bringing progress to an "underdeveloped" country.

The decision to pour in American troops was purely strategic, designed to build a solid wall to contain China and to avert the consequences of waking up the tiger. It was not designed to help our people find a true form of democracy. In fact, if the Americans had not interfered with plans for elections under the Geneva Agreements, the war would not have begun and the Vietnamese people would have been reunited in brotherly love. (The Pentagon Pagers confirmed that the U.S. had sabotaged the plan for elections and reunification of Vietnam because intelligence reports indicated Ho Chi Hinh would have won any elections easily.) Everything can be traced back to the Americans ...

Democracy has been taken away from our country by a capitalist superpower. The United States has not left us alone for a single moment, so that we could together begin rebuilding what she has ruined, because she is afraid that our people, with more than 4000 years experience of nationbuilding, will rise up.

In a way it is true to say we're not ready for democracy (Nixon), or that one cannot expect too much from such an underdeveloped people (Bunker), because it will indeed take us a very long time before we are for American-stlye democracy...

Even inside your own country, which boasts of its civilization and denocracy, many people still live in the most wretched conditions, and only a few capitalists enjoy the fruits of life to excess. If the United States is truly civilized and democratic, why is there so much racial hatred ther My are schools, hospitals, places of business and entertainment segregate between whites and blacks? Why do her laws not protect the weak and the minorities and even the very lives of her citizens, instead of guns and bullets freely used to enforce jungle law?

The spiritual values of American-style civilization and democracy fall short of those found in Asia And Africa. They are like a coat of paint on a piece of wood whose inside has been eaten up by termites.

American democracy is nothing to be proud of. Nor is the fact that American dollars have enabled you to control smaller nations; if the U.S. is really the model of civilization and democracy, then the world cannot last nuch longer... Cont. page 4

I must admit that in our own country there are many traitors whose love of money has made them usurp our people's democratic institutions. But this minority will be run down by the wheel of history and the march of progress of our people will step over their dead bodies ...

Our country may really lack democracy, but it is the kind of democracy that the foreign capitalists are trying to impose on us. We may be underdeveloped, but it is the kind of underdevelopment that we have cultivated through more than 4000 years of nation-building: We cannot tolerate disor der, prostitution, manslaughter, robbery, rape and other such ills. We cannot allow them to corrupt the foundations of our family structure and our morality ...

In short, your country excels our country only in the areas we have al ready rejected. The things you call civilization and democracy only cause us to throw up. As Asians in general and Vietnamese in particular, we stress benevolence, harmony, compassion and spiritual beauty.

We cannot change ourselves into cowboys and act out scenes from the Wild West with blows, knives and guns. So we prefer to reserve this democracy for your enjoyment, Mr. President and Mr. Ambassador. No other country in the world would dare accept it unless it wished to destroy its own culture.

I hope that my humble words arouse your slumbering consciences in time for you to look at yourselves and change your course. I would be most satisfied if you left your high positions and became ordinary citizens again Then you could ask your government permission to come back here and study the good and beauty of a people with a 4000-year-old culture.

And when you came I would be more than glad to bring you into the remote areas of our country and let the patient and hard-working peasants teach you the way.

-- 0 --VAGINAL INFECTIONS (Part VI)

Another infection many women suffer from is cystitis, the medical term for bladder infection. The urine that is stored in the bladder does not normally contain bacteria, so the infection does not start here.

But since the outside openings of the rectum, vagina, and bladder (the Women who have a history of blad-rethra) are close together and since der or kidney infections should drink the whole area is warm and moist, it's easy for germs to spread from he rectum or vagina to the urethra ind bladder.

Bladder infections can occurr in ll women and children, but like vacont. next col.

TI, RIP-OFF? ginal infections they more often occur among women who are sexually involved with men.

> Symptoms: There is pain and burning feeling when you pass urine. You may want to pee frequently, yet when you do there is very little urine in your bladder. In a bad case there may be blood in the urine.

Cause: Several different germs can infect the bladder, including those that are normally present in the rectum. If a woman is diabetic and there is sugar in her urine bacteria will grow and spread more easily.

Treatment: A sulpha drug called Gantrisin is widely used. In some cases the bacteria may be resistant to Cantrisin and an antibiotic like Tetracyline may be used. This medication should bring almost immediate relief from the symptoms, but since the infection is not cured immediately, the medication should be continued for about two weeks.

Women who have side effects, in cluding headaches, when they take Gantrisin are treated with Tetracycline. It is very important to be completely cured of bladder infections. Tany people think that chronic bladder infections may lead to serious kidney disease.

lots of fluids to dilute the urine and flush the kidneys. Pee regularly because the pressure of a full blad der may inflame the tissues, and also because peeing washes bacteria out of the bladder and urethra. (Last chapte of this exciting story next week)

RACIST (cont) quently, they left him alone while RACIST JUSTICE FROM A RACIST the doctor made some temporary repairs and two more policemen arrived to give him a warrant charging him with disorderly conduct. After finishing at the hospital they went back to get a clean unbloodied shirt (couldn't have anyone look like they had just been beaten!) and then

down to the jail.

As a result of this attack Mr. Guyton was left with a dislocated disc in the shoulder. For four months he could not use his hand, and he was out of work for six months—forcing him and his family to life off of the goodness of their friends. However, it is interesting to note that while Mr. Guyton was in jail the City of Charlottesville noid for these Charlottesville paid for these visits, perhaps admitting that they were libel for the damages and hoping that nothing more would come of it.

RACITST JUSTICE FROM RACIST COURTS

When the case come t court, Spitzer gave him 90 days for disorderly conduct and resisting arrest. While Mr. Guyton's arm was still in a cast and sling Judge Spitzer told Mr. Guyton to "shut up" at his own trail and then asked the Charlottesville police if any of them had been hurt. Of course, with the odds of 5 police-men to 1 man, the answer was no. Mr. Guyton appealed the sentence.

When the case came before Judge Coles, the collusion of all racist eléments in American justice became painfully apparent. Mr. Guyten oneverdentieversidenthew Judge Coles, H. G. Haugh, his lawyer, kept Mr. Guyton out in the hall while he went running back and forth between his client and the judge. Finally, the word came out that he would have to serve 30 days because, "If they turned him loose, everybody in Charlottesville would be whuppin' up on the policemen." So, Mr. Guyton went to jail.

However, Mr. Guyton only stayed in jail for ten days at which time he was released to the custody of his employer. This release was not the blossoming of any benevolence on the part of the police or Charlottesville power structure: but rather, as Mr. Guyton was later told by an official, because keeping him in jail was costing too much money in medical bills--\$30 to \$40

a day. TAWYER BE SECOND TO STAW

During all of this, it was requested of H. G. Haugh, Mr. Guyton's lawyer, that he do something about his police brutality in some sort of counter-suit. Indeed, when Mr. Guyton's doctor examined the wounds made by this brutal police action, he was so shocked that he asked for Haugh to come talk to him about the beating and injuries of his client. Mr. Haugh never came down to the hospital as he was asked. He also clarified his position on racist, police brutality by sayin, "I'm not going against the police." RACISM NO MORE!

So where has all of this left Mr. Guyton? Because he could not afford it, he has been deprived of physical therapy which is necessary for him to learn how to best adjust to the permanent damage done by the police.

Mr. Guyton has not been intimidated though. He told the Virg-inia Weekly, "I'm still interested in getting my shoulder back in place, in being repaid for the time I was off work, and in why they can just walk through people's doors and just do whatever they want to do. That Jimmy Pace and that Dave Pleasant, something has just go to be done about them. They keep agitating and agitating, trying to force you into something. There's just so much a man can take, you know. I've never been one for marching and carrying signs, but what's right is right."


SEXISM SPREADS THROUGHOUT THE GALAXY

NEW YORK(LNS) -- As if sexism here on earth isn't bad enough, it's no catapultaing its way through the vast reaches of the Galaxy as part of U.S. scientists message to other planetary civilizations. The Pioneer 10 space ship launched Feb. 26, is on the longest space mission in history to date. Its mission? To send back to earth some two years from now, close-up pictures and scientific observations of Jupiter.

And perhaps more importantly the Pioneer 10 will announce our existence to possible distant civilizations through symbols engraved on a gold-coated aluminum plate. The two symbols formost on the plate are drawings of man and woman. Man's hand is raised in a friendly salute—and you guessed it—the woman is standing

passively at his side.

Other less controversial symbols include one which shows the two states of the hydrogen atom as the unit of time and distance used. A star-like diagram shows the position of the earth relative to 14 stars that emit radio pulses at regular rhythms. Man and Woman stand in front of a diagram of the spacecraft and at the bottom of the plate there is a representation of the solar system which shows that the Pioneer 10 was launched from the third planet from the sun.

CHINOISERIE

One of the more visible repercussions of Richard Nixon's China trip has been a sudden American appetite for things Chinese. In New York City's China Town, according to one food wholesaler's estimate, restaurant business has increased 25% since the President went to Peking. Part of the rise may be due to the recent Chinese New Year, but the televised spectacle of the Nixons sitting down to eightcourse Mandarin dinners obviously set many salivary glands to work.

Across the nation, there was a great fumbling and clicking of chopsticks—an item that restaurants often ran out of, as Americans accustomed to forks and chop suey suddenly demanded authenticity. Instead of the familiar Cantonese cuisine, spicier Mandarin dishes enjoyed a vogue. Some adventurous diners even demanded preserved eggs and shark—fin soup.

There was, of course, no evidence that the Chinese were overcome by a corresponding yen for hamburgers.

In several weeks Harrisonburg will have an election. Councilmen (no women are running, natural. ly) will be chosen at this time. This election might prove quite different when compared to past exercises. Before, the question was not a question one worked himself up about. One candidate was relatively close to all the others running. Some were Democrats while the others Republican But this time the race has an able Black man and a student in the contest. City Hall (officers and cronies) is worried. They are scared, actually frightened of these two candidates. Blakey, Jr.) Talk to other students, try to encourage them to register and vote also. I often talk of power to the people.
