PURPOSE:

To express the desires of a number of students to the administration in a manner that circumvents the established procedures of the S.G.A. and Inter-Dorm council, which have proved themselves to be inneffective and non-responsive in the past.

To motivate the student body to take action to overcome the dictator: and repressive rules and regulations under which we live.

We are not demanding anything, but meerly asking WHY and WHY NOT. We ask that you, the students, get concerned about the way we have to live and help us do something about it.

The purpose of the mass meeting on Wednesday is two fold: It is an effort to get President Carrier and/or Dean Fox to explain certain things to the student body as a whole. Also we will explain what has been requested and accept suggestions from the students, as it is you that we represent.

We would like answers to and action on the following:

- 1. Is it true that the dorm rooms are checked during vacations for other than maintenance reasons? If so, for what reason and why aren't the residents told?
- 2. If the dorm wants it, why can't we have open house during the week?
- 3. Will all the dorms be granted autonomy? Also, a complete definition of autonomy and of standard and modified dorm concepts.
- 4. What valid reasons are there for requiring freshmen and sophomores to live on campus?
- 5. We see no reason why we can't implement 24hr. dating and study lounges NOW.
- 6. Can the hours of the Student Union and Library be extended next year as there will be no curfew?
- 7. Can we start an experimental co-ed dorm?
- 8. What is the story behind the rumor that RAs and House Mothers fill out confidential reports on students that go on their permanent records? These people are not qualified to make influential judgements about students.
- 9. We would like the general social policies for next year to be make public before contracts for rooms on and off campus are signed; all loop-holes and weak points should be cleared up now.
- 10. We feel that house mothers (as the system now stands) serve a more detrimental than constructive function. Head Residents, as in mens! dorms, graduate students, or married couples, could preform a more meaningful and relative function and we would like to have these new ideas experimented with.
- 11. If curfews are to be phased out next year, WHY NOT NOW??
- 12. Why can't students keep refridgerators in their rooms or suites?
- 13. Eliminate bureaucratic red-tape in getting things done!
- 14. Re-evaluate basic studies NOW!


OPEN DORM PETITION

Some of you, especially those of you who signed it, are probably wondering what happened to the Open Dorm Petition. Well, it was finally turned in to the SGA.

Wed. night. It wasn't due to negligance that it wasn't turned in sooner but rather we thought it best to turn it over to the new SGA in order to make sure that it didn't end up in the trash can as it might well have done under the old do-nothing SGA. We have hopes that this SGA will prove to be more interested in the students.

Also many people were wondering how successful the petition was. A total of 2,201 people signed the petition. This number grows significantly when one considers that about 90% of the seniors did not sign the petition, and most day students did not even see it. Looking at the results it is obvious that the majority of dorm residents are very much interested in a new ploicy regarding open dorms. Such a policy would have to be based on individual dorm determination (as the petition suggests.) The petition is before the SGA and The Fixer will keep you informed on it's progress along with other information dealing with the same subject.

#### LIPTON REPORT

Last week one of our staff mentioned that we would print the entire report of the Faculty Grievance Committee, which found that Dr. Lipton had been fired without just cause and should be offered a new contract. We want to know how you feel about the staff collective STANDARD, MODIFIED, BUT WHY NOT LIBERAL?

Recently in the girl's dorms (and maybe soon in the men's) a form was passed around asking the girls to select the type of dorm they wished to live in-standard or modiried. This is a real step to beginning individualized dorms, resident halls where people would know what they were getting into. It is good for all people because now those who are hassled by the noise and confusion of Open Dorms can live in an environment free from this and those who do want Open Dorms can no longer be harassed out of having them with the pretense of disturbing others. Still, though it is a step in the right direction, it appears to be more of a half-step with no real choice being offered. Standard dorms are dorms that have the normal school social rules which will include (by next year) alcohol in the room and no curfew for the girls. Modified dorms are those with no open dorms (ever?) and no alcohol. I would like to suggest a third choice -- the liberal dorm. This could be a dorm which would have things like 7 day open dorms and perhaps 24 hour open dorms on weekends (sounds so radical for Madison, but it is happening on the majority of college campuses, even those in Va.) The National and State governments have already recognized that 18 year olds are mature enough to vote for the President and Governor, and Va. has even made 18 the legal age for majority. If the Nation and State recognize our maturity why won't the college. To make it even better for the college the liberal dorm could be run on a parental permission basis. This would protect the college from irate parents. I am sure that there are a few people on this campus whose parents trust them and be-lieve them to be mature and responsible enough to handle such a dorm situation. This seems so simple, something for the students who wish to live without hassles (and parental approval) and being responsible for themselves, which is supposedly what college is all about. And it also has an escape clause for the college. Why couldn't it work? I would appreciate any comments from students and especially from the Administration via The Fixer.
