BOI Conclusions:

1. The investigation report concluded that the main contributing factor was ignorance of SOPs by deminer in terms of conducting wrong drill during excavation. And also the poor supervision by command group is another contributing factor as the deminer was not stopped from conducting wrong drill.

## **Analysis**

The primary cause of this accident is listed as Inadequate training because the investigators found that the Victim did not know how to excavate safely. The secondary cause is listed as a Management Control Inadequacy because it is a management responsibility to ensure that all deminers are appropriately trained.

The facial injury implies that the visor was not worn correctly. The summary of the accident is inadequate and reports simply that a “wrong drill” was conducted. It may be that the deminer failed to pinpoint the detector reading adequately or that he began to dig on top of the site of the detector signal without realising the dangers involved.

The “Inadequate investigation” listed under notes refers to the absence of a full accident report. The UN supported MACCA has failed to make these widely available for some years in contravention of the requirements of the IMAS. The failure of the UN to share the Afghan investigators’ work with others is regrettable.
