Accident investigation completed. Action taken.

1. The accident has occurred because of deminer's carelessness as he entered into unsafe area for urination and touched the unknown item.
2. Unavailability latrine which is an essential facility for every demining worksite can be considered as one of the main contributing factors to this accident.
3. The area has been disturbed and made the work of investigation team bit difficult on finding the reasons for this accident. This is against the AMAS chapter 26.6.a.
4. The report of this accident has not been passed on time to the respective AMAC. AMAC has been notified about the accident after 24 hrs which is considered as a non-conformance with the AMAS chapter 26, paragraph 26.8.

Analysis

The primary cause of this accident is listed as a *Field Control Inadequacy* because the investigators found that the demining site did not have a latrine facility and the accident site had been disturbed before they could investigate. The secondary cause is listed as a *Management Control Inadequacy* because the demining group's senior management should have ensured that the site was properly laid out, the accident site undisturbed, and the accident report made immediately, as required by the MAC.

The Victim “touched” a UXO without apparently realised the threat it posed, which implies that he did not know the risk he was taking and his ignorance is the *Inadequate training* listed under Notes.

The “Inadequate investigation” listed under notes refers to the absence of a full accident report. The UN supported MACCA has failed to make these widely available for some years in contravention of the requirements of the IMAS.
