BOI Conclusions:

1. It is the conclusion of investigation team that the carelessness of involved ATL, deviation from AMAS and [Demining group]'s SOP and use of dark visor during disarming operation on the fuse are the contributing factors to this accident. Additionally the rule of supervision is vital in preventing such accidents.

Analysis

The primary cause of this accident is listed as Victim inattention because the investigators determined that the Victim as careless. The secondary cause is listed as a Management Control Inadequacy because the investigators found that the demining group management had issued inappropriate PPE.

The Inadequate equipment listed under notes refers to the issue of a "dark visor" which the investigators found to be a contributory cause.

It is not certain whether the mine detonated, or just the fuse. The "crush" injury to the Victim's arm is unexplained.

The "Inadequate investigation" listed under notes refers to the absence of a full accident report. The UN supported MACCA has failed to make these widely available for some years in contravention of the requirements of the IMAS. The failure of the UN to share the Afghan investigators' work with others is regrettable.
