It is the conclusion of the investigation team that the carelessness of involved deminer, use of wrong tool for excavation and poor supervision caused the accident happened.

COMMENT: Fatal. No details provided. No Medical report was made available.

## **Analysis**

The primary cause of this accident is listed as a *Field Control inadequacy* because the investigators found that there was poor supervision at the time of the accident. The secondary cause is listed as *Other* because there is not enough detail in the summary to determine what the deminer was doing, and what tool he was using. Because fatal excavation accidents are rare, it is likely that the Victim was not wearing PPE appropriately and/or that there was a problem applying appropriate trauma care in a timely manner.

The “Inadequate investigation” listed under notes refers to the absence of a full accident report. The UN supported MACCA has failed to make these widely available for some years in contravention of the requirements of the IMAS. The failure of the UN to share the Afghan investigators’ work with others is regrettable.
